**Registration Fee:** The registration fee is \$75 per person. **Please ensure that your registration is postmarked BY MARCH 1st.** Limited scholarships are available upon request. **Cancellation Policy:** If you register for the workshop and are unable to attend, please notify us in writing prior to the workshop.
