## REGISTRATION INFORMATION & CHECKLIST

- Registration** Group director should submit one registration form and the attached dancer release form by September 1<sup>st</sup>. Release form **MUST BE SIGNED BY ALL DANCERS**. Release for dancers under 18 must be signed by a parent or legal guardian. Dancers will **NOT** be allowed to participate if the release form is not signed.
- Payment** The participation fee is \$20 per group. The participation fee for soloists registering independently is \$15. Full payment is required with registration. Checks should be made payable to Guidance Dance Company. Please do not mail cash.
- Video or DVD** With your registration, please send a video of all dance pieces. While this is not an audition, Guidance Dance Company reserves the right to make suggestions and adjustments in the areas of costuming, music, and content. All pieces must be family friendly.
- Music** With your registration, send 2 copies of your music for each piece. Music for each piece should be on **separate** CDs. No cassette tapes, DAT tapes or iPod music will be accepted. Use a Sharpie marker to clearly label the CDs with your group name and the piece title.
- Scripture Verse** For each piece submitted, please include a corresponding scripture verse. This verse will be printed in the program. **The verse should relate directly to the content of your piece.**
